### Nestlé Waters

- Benner Township and Spring Township – the two townships that have potential to be affected if the project moves forward – have been and remain very supportive of the project!
- Some opposition to the project has been voiced. This comes primarily from Ferguson Township, and in particular from two of the Ferguson Township supervisors. They have posted comments on social media and also voiced their thoughts at the January 16 Ferguson Township Board of Supervisors meeting (Watch the full meeting [here](#)).
- Nestlé Waters, on Friday, January 19 and in conjunction with State Representative Hanna, donated 1,600 *FREE* bottles of water to residents serviced by the Mountaintop Regional Water Authority (Read more [here](#) or [here](#) [CDT coverage]).
